# INTRODUCTION

Medical Insurance is one of the fastest growing classes of business in the region constituting a significant portion of the gross written premium of short term business in East Africa with 30% being written in Kenya, 23% in Tanzania and 16% in Uganda. The medical class of business has potential for exciting, innovative developments but is plagued with challenges of increasing medical costs, high loss ratios and fraud.

The Medical Insurance Workshop is the first of its kind, aimed at addressing the skills required to underwrite, price, manage and reinsure the largest short-term business class in Kenya. The course will equip participants with the technical knowledge and skills that will enable them carry out their tasks in an efficient manner with the ultimate aim of improving the results of this class of business.

# **WORKSHOP OBJECTIVE**

#### The objective of the workshop is to:-

- 1. Appraise participants on the status of the medical insurance and reinsurance industry by providing results of analytics performed.
- 2. Discuss in detail the pricing techniques for medical insurance
